

### **Violence against Women and Children**

July 24, 2019, New Delhi

The Indian Association of Parliamentarians on Mr. Manmohan Sharma, Population and Development (IAPPD), the nodal parliamentarians' association to deliberate upon population and development issues, organized a Women Parliamentarians' Meet on 'Violence against Women and Children' on July 24, 2019 at the Parliament Annexe, New Delhi. The objective of the meet was to deliberate upon the issue in detail and discuss the way out to make India a safe place for its women and children.

Around 35 Parliamentarians from both the Houses of the Parliament and across all political parties participated in the discussion. Efforts towards addressing women issues and women empowerment also require the participation of men and consequently, few men Parliamentarians also participated in the discussion. The Chief Guest of the meet was Smt. Smriti Zubin Irani, the Hon'ble Union Minister for Women and Child Development, Government of India. Former Deputy Chairman of Rajya Sabha and the Chairperson of IAPPD, Prof. P.J. Kurien, chaired the discussion.

Secretary, IAPPD, welcomed the Hon'ble Minister and all the Parliamentarians attending the discussion.

The Vice-chair of IAPPD, Ms. Viplov Thakur, MP, too welcomed the Hon'ble Minister and all Parliamentarians. In her Smt. Smriti Zubin Irani, Hon'ble welcome remarks. said that Hon'ble Minister Child Development, addressing is an epitome of women empowerment in India.

Ms. Thakur shared her apprehensions and concerns over the unprecedented rise in the crime against women and children despite the strong legislations in the State - including Dowry Prohibition Act, Protection of Women from Domestic Violence Act and the legislation against female foeticide. #### From the Desk of the Editor



Enjoyment of women's human rights is constrained by violence against them everywhere. As we all know that it is an expression of power and control and an instrument to maintain gender inequalities, disrupting the health, survival, safety and freedom

of women and their families around the world. To end violence against women, girls and children, we must ensure their full empowerment, promote and protect their rights, including access to justice and support services, and end the discrimination they face in all aspects of their lives.

Priority for government, communities and families must be towards zero tolerance for violence against women and children. In India, much has been done by the government over the past few decades, for legal and policy reforms, extension of services to support and protect women and children from domestic and sexual violence. Also, preventive efforts have focused on advocacy and campaigns that have brought the issue into public consciousness.

Parliamentarians, being the policy makers of the country, have an onus of eradicating this social evil. Also, involvement of socializing institutions such as educational institutions, religious groups and organizations, popular film stars and sports personalities surely help prevention of violence against women and children.

Against this backdrop, IAPPD, the nodal parliamentarians' association to deliberate upon population and development issues, organized a Parliamentarians' meet on "Violence against Women and Children" on 24th July 2019 at Parliament Annexe. The objective of the meet was to deliberate upon the issue in detail and discuss the way out to make India a safe place for its women and children.

Around 35 parliamentarians from both the Houses of the Parliament and across all political parties participated in the discussion. Efforts towards addressing women issues and women empowerment also require the participation of men and consequently, few men parliamentarians also participated in the discussion. The Chief Guest of the meet was Smt. Smriti Zubin Irani, the Hon'ble Union Minister for Women and Child Development. The discussion was chaired by Former Deputy Chairman of Rajya Sabha and the Chairperson of IAPPD, Prof. P.J. Kurien.

During the discussion, it was felt that restricting and ending violence requires coordination and convergence within different ministries and not in isolation with the Ministry of Women and Child Development as well as with the Ministry of Health and Family Welfare. It requires a coordinated response and efforts beyond the two Ministries beyond judicial and legal protection. There is a need to involve Ministries like finance and employment, small enterprise, housing, transport, urban planning in its ambit. The Hon'ble Minister strongly holds the opinion that the proactive attitude of the Members of the Parliament and their inclination to take responsibilities and initiatives brings about great changes at ground level.

the Ministry would enable the enthusiastic women Parliamentarians to effectively address the issue of violence against women and children.

A thematic presentation on 'Status of violence against women – Issues, myths and challenges' was made by UNFPA.

The Hon'ble Minister of Women and Child Development, Mrs. Sriti Zubin Irani opined that such type of forum is important where the Members of Parliament come voluntarily without any party whip; and share their views and deliberate upon important social issues. About queries related to the strengthening of the schematic interventions in the respective constituencies of the parliamentarians, the Minister gave certain suggestions. She strongly holds the opinion that the proactive attitude of the Members of the Parliament and their inclination to take responsibilities and initiatives brings about great changes at ground level. In order to curtail the violence against women, the Minister suggested certain interventions.

The Minister assured the Parliamentarians that she is always available as the Minister of Women and Child Development and is ready to provide whatever infrastructural requirements are needed. But, she requested the Parliamentarians that they need to assert their role on the ground as they know the best at grass-root level and the same can be communicated to the minister for necessary interventions.

Mr. Avinash Rai Khanna, former-MP; Vice President, Bhartiya Janta Party; Vice Chair, Indian Red Cross Society, shared instances from grass root level and highlighted that family is the first place where the girl starts facing discrimination and injustice.

During discussion session, one of the parliamentarians expressed her concerns over the way one-stop centers have been working. She particularly highlighted lack of infrastructure - both manpower and physical and urged for the need to equip these centers for its proper functioning. She suggested that the Ministry should formulate and implement some monitoring mechanisms. Steps should also be taken to increase the visibility of these centers.

A similar concern is also shared by another parliamentarian from Assam. She said that there is only one One-Stop-Centre operational in Assam and that too is working in deplorable condition. The situation of women in Assam demands some more operational One-Stop-Centers in the state. The situation of the Remand Houses and State Homes is no less good. Given such a scenario, the parliamentarian wanted the support of the Ministry so that she could work on the same. The Hon'ble Minister informed that she is going to write a letter about the implementation of POCSO

Amendment Act and other acts soon. This would enable the parliamentarians to seek information on POCSO related cases from the District Superintendent of Police and District Magistrate during the DISHA meetings (The Centre formed District Development Coordination and Monitoring Committee to be named as "Disha" for effective development coordination of almost all the programmes of Central Government). This will be done concerning the One-Stop-Centres also and the letter would enable the law-makers to strengthen the scheme in their region.

Another Parliamentarian shared her apprehension towards the lack of sensitivity and unresponsive behaviour of the personnel posted at the Helpline as well as of Mahila Police Stations. She suggested the need for creating awareness and sensitizing the personnel.

A parliamentarian from Odisha shared about the lack of awareness not only among the common people but also among the law-makers about these schemes in their state, especially in tribal areas. The authority should create awareness among the lawmakers on the same. Additionally, the Ministry should also assist and help the law-makers to have access to state-wise contact numbers and details of one-stop-centers.

Another parliamentarian suggested that one policy would not cater to the needs of diverse women

population in the country. The issues and challenges of women in different geographical region and rural and urban areas are very different. Different strategies and schemes are required to mitigate these challenges and issues.

A parliamentarian from Andhra Pradesh said that there is lack of awareness among various stakeholders (including legislatures) about various government schemes and programmes to stop violence against women and to help women suffering from violence. She seeks the suggestions and guidance from the Ministry for creating awareness not only in her constituency but also in others.

Another parliamentarian believed that property/house ownership by women also protects women against violence. Formulating, introducing and implementing schemes emphasizing or on inclusion of property ownership by women or including such provisions

in the existing schemes like in the BBBP Programme (*Beti Bacho Beti Padho*) should be taken into consideration to curtail and eliminate violence against women. However, the Minister cautioned that such an initiative would be highly misused.

One of the women parliamentarians, who is a professional medical practitioner, believes in prevention is better than cure. She suggested that the government should make it mandatory to include moral science within the curriculum and strengthen it. Moral science or moral education inculcates in our children

good values that have been part of our rich culture. She further added that the ideas and values that the children get in their childhood remain throughout their lives. It is a period where the child's behaviour can be reformed and moulded.

There was also a suggestion from a parliamentarian to separate women call centers from police stations as women often restrict themselves from going to police station as they conceive them as unfriendly and insensitive towards their issues.

While giving an account of the Mahila Suraksha Abhiyan that was conducted in Odisha in the year 2018, a parliamentarian shared that each woman was given the charge of three parliamentary constituencies.



Despite such initiatives, the crime rate against women and children continues to be alarmingly high. The Ministry should take stringent steps and take initiatives for the effective operations of the programme.

The discussion ended with the vote of thanks and hopes that these suggestions and advice would be carried forward.

The concluding speech was given by Prof. P.J. Kurien. He said that there is a need to bring about attitudinal change in men. He lends his support that the school curriculum should have moral science/lesson right from the primary and foundational level. The education system should teach them the relation between girls and boys.

This initiative supports the Government of India's ambitious goal of eliminating TB by 2025, which would be five years ahead of the UN's Sustainable Development Goal. The initiative creates a shared platform for corporations committed to ending TB in India. The event was held in partnership with the American Chamber of Commerce in India (AMCHAM India) and the Confederation of Indian Industry (CII). Mr. Manmohan Sharma, Secretary, IAPPD attended the launch ceremony.

Speaking at the event, Ambassador to India noted, "The United States is proud to be working with the Indian government to bring the corporate sector and civil society together to seek to eradicate this devastating but curable disease. # **India: Civil Society Representatives and Community Partners meet in Delhi - India CSO Partners Meeting**

June 27, 2019, New Delhi

The Global TB Caucus hosted a meeting of key CSO partners engaged in parliamentary advocacy around TB in New Delhi on June 27, 2019. Participants at the meeting used the opportunity to plan for next steps in engaging with Parliamentarians in the national post-UN High Level Meeting (UN HLM) and post-election landscape. Representatives from the Centre for Legislative Research and Advocacy (CLRA), the Global Coalition of TB Activists (GCTA), the Global Fund Advocates Network (GFAN) India Working Group, the Global Fund, Global Health Strategies (GHS), the Indian Association of Parliamentarians on Population and Development, (IAPPD), the International AIDS Vaccine Initiative (IAVI), the India HIV/AIDS Alliance, PRS Legislative Research, REACH, and The Union were present and participated in the discussion. IAPPD was represented by Mr. Manmohan Sharma, Secretary. He highlighted the role of Parliamentarians in the seminar.

India has the highest TB burden in the world and was home to over one quarter of all new infections and deaths in 2017. Each year India loses over 420,000 people to TB. Over the past years, the Indian government has shown strong commitment to fight the national TB epidemic. In March 2017, Prime Minister Mr. Narendra Modi announced that India would end TB by 2025, 5 years before the global target.

Over the course of the meeting, partners presented their work thus far in engaging elected representatives, and proceeded to work in groups to map up-coming opportunities and the distribution of responsibility for the coming months. Technical sessions on the global work of the Global TB Caucus, the UN High Level Meeting on TB and the composition and history of the India Parliament were conducted in order to build context around TB advocacy plans and priorities. The meeting concluded with participants agreeing on a work plan and action framework that will guide coordination and collective action for the coming months.
