South-East Asia Regional Coordination Mechanism Forum (SRCMF), fostering regional collaboration on pressing population and development issues. Our participation throughout 2024 and early 2025 has contributed to a shared vision for sustainable and equitable growth in the region.

# Meeting with Union Minister for Social Justice and Empowerment on Old Age Care in Rural India

# IAPPD Standing Committee Meeting on SDGs Parliamentarians Discuss Strategies to Address Teenage Pregnancies and Malnutrition in India

IAPPD convened its Standing Committee Meeting in New Delhi, focusing on "The Role of Parliamentarians in Accelerating the Achievement of SDGs: Addressing Teenage Pregnancies and Malnutrition among Children in India" in New Delhi on 11th December, 2024.

Presided over by Mr. Harivansh Narain Singh, Deputy Chairman of the Rajya Sabha, the meeting featured Mr. Bhubaneswar Kalita, Vice Chairman of IAPPD and Chairman of the Parliamentary Standing Committee on Science and Technology, as Guest of Honour. Prof. P.J. Kurien, former Deputy Chairman of the Rajya Sabha and Chairman of IAPPD, chaired the session, with participation from Parliamentarians and experts.



## **Key Discussions and Recommendations**

### **Teenage Pregnancies & Malnutrition:**

- Prof. P.J. Kurien stressed that teenage pregnancies contribute to maternal and infant mortality, while
  malnutrition affects millions, causing stunting and wasting. He urged policy interventions to combat these
  issues.
- Mr. Harivansh Narain Singh highlighted socio-economic and cultural influences, calling for enhanced education, health awareness, and legal measures.
- Mr. Bhubaneswar Kalita advocated for stronger policies and legislative reforms to support young girls and children.

# Parliamentarians' Recommendations:

- **Gender Equality Advocacy:** Promote policies empowering girls through education, healthcare, and employment.
- **Stronger Child Marriage Laws:** Enforce the Prohibition of Child Marriage Act, 2006, and advocate for raising the legal marriage age for women.
- Comprehensive Sexuality Education: Introduce age-appropriate reproductive health education in schools.



- **Improved Healthcare Access:** Expand reproductive health services, particularly in underserved areas.
- **Enhanced Nutrition Programs:** Strengthen ICDS, Mid-Day Meal Scheme, and POSHAN Abhiyaan.
- **Socioeconomic Support:** Implement financial incentives for families to delay marriage and pregnancy.
- Community Engagement: Partner with NGOs to challenge societal norms around early marriage and teenage pregnancies.

#### **Expert Insights**

- Dr. S.K. Singh (IIPS Mumbai) shared NFHS-5 findings, emphasizing education and family planning to prevent early pregnancies.
- Dr. Sanjay Kumar (UNFPA) highlighted how early marriage disrupts education and perpetuates poverty, urging integrated solutions.

## **Tackling Malnutrition**

- **Food Security:** Strengthen PDS and promote nutrient-rich food production.
- Maternal Health: Improve antenatal care, iron supplementation, and breastfeeding support.
- **WASH Initiatives:** Advocate for better sanitation to prevent nutrition-linked infections.
- **Tech & Data:** Leverage data-driven policymaking to track and combat malnutrition.
- **Women's Empowerment:** Focus on education and economic opportunities to improve child nutrition.

#### Conclusion

The meeting underscored the importance of a multi-sectoral approach, combining legislative action, grassroots advocacy, and policy reform. Parliamentarians pledged to drive initiatives addressing teenage pregnancies and child malnutrition,

reinforcing their commitment to achieving India's SDG targets. The session concluded with a vote of thanks, reaffirming the collective vision for a healthier future.





# 7th Sat Paul Mittal Memorial Lecture at JNU Hon'ble Justice Aravind Kumar Delivers Insightful Lecture on Elderly Care

The 7th Sat Paul Mittal Memorial Lecture, organized by the Indian Association of Parliamentarians on Population and Development (IAPPD) in collaboration with the Centre for the Study of Regional Development (CSRD), School of Social Sciences, Jawaharlal Nehru University (JNU), took place on February 18, 2025, in New Delhi. Hon'ble Justice Aravind Kumar of the Supreme Court of India delivered a compelling lecture titled "Parental Care, Obligation, and Rights of Elderly Parents: Moral and Legal Perspectives."

The event was presided over by Prof. P.J. Kurien, Chairman, IAPPD, with Prof. Dipendra Nath Das, Rector, JNU, as the Chief Guest. Other distinguished attendees included Prof. Kaushal Kumar Sharma, Dean,

# 9th Sat Paul Mittal National Inter-University Debate Competition 2025 on "The Climate Crisis is Posing a Threat to Human Health"

The Indian Association of Parliamentarians on Population and Development (IAPPD) successfully hosted the 9th Sat Paul Mittal National Inter-University Debate Competition 2025 from February 28 to March 1 at the IAPPD Auditorium, New Delhi. The event brought together students from 14 universities across India, fostering dynamic exchanges on the crucial topic: "The Climate Crisis is Posing a Threat to Human Health."

This thought-provoking debate highlighted the extensive impact of climate change on human health, covering critical issues such as rising temperatures, air pollution, and the spread of



infectious diseases. The participants presented well-researched arguments, offering diverse perspectives on the intersection of environmental and public health concerns.

#### **Inaugural Session**

The event commenced with an inspiring inaugural session featuring Dr. Balakrishna Pisupati, Country Head, United Nations Environment Programme (UNEP), as the Chief Guest. Prof. P.J. Kurien, former Deputy Chairman of the Rajya Sabha and Chairman of IAPPD, presided over the session. Mr. Bhubaneswar Kalita, MP and Vice Chair of the IAPPD Standing Committee, graced the occasion as the Special Guest. The debate was successfully convened by Prof. Sudesh Nangia, Technical Expert at IAPPD.

Prof. P.J. Kurien played a pivotal role in ensuring the event's success with his strategic leadership and unwavering commitment. Mr. Manmohan Sharma, Executive Secretary of IAPPD, was instrumental in the seamless execution of the debate competition.



#### **Valedictory Session and Award Ceremony**

The competition concluded on March 1, 2025, with a grand valedictory session. Dr. Iqbal Singh Lalpura, Chairperson, National Commission for Minorities, Ministry of Minority Affairs, Government of India, graced the event as the Chief Guest. Mr. Avinash Rai Khanna, former MP and Vice Chair of IAPPD, addressed the participants and congratulated them on their insightful contributions.

The event concluded with the felicitation of winners, recognizing the most impactful debaters and teams for their outstanding performances.



#### **Winners and Awards**

The University of Kashmir secured the first prize in the university category, while Guru Nanak Dev University, Amritsar, emerged as the runners-up. In the individual category, Mr. Gopesh from DAV University, Jalandhar, claimed the first prize, followed by Ms. Kasis Mukesh from Kannur University, Kerala, in second place, and Ms. Shreejita Ghosh from Vidyasagar University, West Bengal, in third. Additionally, consolation prizes were awarded to Ms. Palak Rajput from Barkatullah University, Bhopal; Mr. Toniho Kharsati from NEHU, Shillong; and Ms. Muskan Thakur from the University of Jammu.

The debate provided a national platform for students to engage in critical thinking and policy-oriented discussions. A distinguished panel of experts evaluated the participants, ensuring a robust and insightful competition.

#### **Key Recommendations from the Debate**

- The discussions during the debate underscored several urgent health concerns arising from climate change. Key recommendations included:
- Health Impacts of Rising Temperatures: Addressing increased cases of heatstroke, dehydration, and higher mortality rates due to extreme weather events.
- Spread of Infectious Diseases: Tackling climate-induced spread of vector-borne diseases like malaria and dengue, as well as waterborne diseases due to floods.
- Air Pollution & Respiratory Diseases: Mitigating air pollution to reduce asthma, lung diseases, and cardiovascular ailments.
- Food & Water Insecurity: Ensuring food security by stabilizing agriculture against climate disruptions and improving access to clean water.
- Mental Health Crisis: Addressing the psychological impacts of climate-related disasters, including anxiety, PTSD, and "eco-anxiety" among youth and vulnerable populations.

The debate competition reaffirmed the significance of addressing climate change as a major public health concern and highlighted the role of youth in shaping climate-conscious policies. IAPPD remains committed to fostering critical discussions on pressing global challenges and empowering young minds to contribute to sustainable solutions.



# A Challenge Met by IAPPD:

# Sensitization Workshop for KAAC & NCHAC on Health & Development

Diphu, Assam | 22nd March, 2025

The Indian Association of Parliamentarians on Population and Development (IAPPD) successfully organized a Sensitization Workshop for the Council Members of the Karbi Anglong Autonomous Council (KAAC) and the North Cachar Hills Autonomous Council (NCHAC) in Diphu, Assam. The workshop focused on key issues such as early marriage, malnutrition, malaria, maternal and infant mortality, and their alignment with the Sustainable Development Goals (SDGs).

The workshop was presided over by Mr. Bhubaneswar Kalita, MP and Vice Chair of IAPPD, alongside Mr. Amarsing Tisso, MP, Diphu, Assam. The event witnessed the participation of important dignitaries and 61 Council Members from KAAC and NCHAC, with a total attendance of approximately 100 members from the two autonomous councils.

## **Objectives and Focus Areas**

The primary aim of the workshop was to sensitize legislators and council members on critical health and development challenges in the region. Key areas of discussion included:

- Strengthening Policies & Governance: Encouraging local policies to prevent early marriage, improve maternal-child health, and combat malnutrition and malaria while integrating SDGs into district planning.
- Enhancing Community Engagement: Conducting outreach programs and involving local influencers to drive awareness and behavioral change.
- Improving Healthcare Access: Strengthening primary healthcare centers and ensuring adequate nutrition, immunization, and malaria prevention programs in remote areas.
- Promoting Capacity Building: Training council members, healthcare workers, and community leaders on health and development best practices.
- Fostering Collaboration: Strengthening partnerships between government agencies, NGOs, and global organizations to adopt a holistic approach.
- Utilizing Data for Decision-Making: Establishing monitoring systems to track progress and guide policy decisions using evidence-based insights.

#### **Key Outcomes**

The workshop highlighted the urgency of addressing these health and social issues and emphasized the role of council members in advocating for sustainable solutions. The discussions underscored the importance of integrating SDGs into local governance to ensure holistic and long-term improvements in community health and well-being. This initiative by IAPPD reflects its ongoing commitment to empowering policymakers with knowledge and resources to drive impactful change, ensuring a healthier and more sustainable future for the people of Assam.

# Addressing an Emerging Concern: Ageing Population in India

India's elderly population is growing rapidly, presenting unique challenges in healthcare, economic security, and social inclusion. Many seniors, especially women, face financial dependency, loneliness, and limited access to healthcare. Addressing these concerns requires collective action from the government, civil society, and local communities.

The Indian Association of Parliamentarians on Population and Development (IAPPD) has been at the forefront of raising awareness and engaging policymakers in elderly welfare initiatives. On August 22, 2024, an IAPPD delegation visited two impactful elderly care initiatives in Hoshiarpur, Punjab: the Rayat-Bahra University's Rural Project on Ageing and Sanjeevni Sharnam, an urban ageing initiative. These visits provided valuable insights into successful models that could be expanded and replicated across India.

#### **Bridging Generations: Rayat-Bahra Rural Project on Ageing**

The Rayat-Bahra Group of Institutions, under the leadership of former MP Shri Avinash Rai Khanna, has initiated a project aimed at supporting elderly individuals living alone in rural areas. The project operates on the philosophy: "Saanb lao Maape—Rab Mil Jai Appe" (Take care of your parents, and you will find God). Female students from Baba Auragh Fatehmath Girls College visit elderly residents every Sunday, offering companionship and practical assistance, alleviating loneliness, and fostering intergenerational bonds.

During their visit, the IAPPD delegation interacted with elderly beneficiaries who expressed deep gratitude for the support and emotional warmth provided by the students. Additionally, the team explored Rayat-Bahra's medical facilities, where nursing students guided seniors through health check-ups and wellness education, easing fears about healthcare access.

# A Model for Urban Elderly Care: Sanjeevni Sharnam

Sanjeevni Sharnam, a CSR initiative by Sonalika Tractors, was established in 2014 to provide a structured and engaging environment for urban seniors. Led by Ms. Sangeeta Mittal, the center offers a mix of paid specialized care (including therapy services) and free community activities for over 500 registered members, known as "Sharnamites."

Daily activities range from meditation and yoga to social games and cultural discussions, fostering mental and physical well-being. The center also organizes periodic events such as movie



screenings, festival celebrations, and an annual sports day. The visiting IAPPD team observed how these activities significantly enhanced the seniors' quality of life, promoting active and joyful ageing.

# Recommendations for Scaling and Strengthening Elderly Care Initiatives

Both projects demonstrate effective approaches to elderly support, but there is room for expansion and improvement. The IAPPD team proposed several recommendations:

- Expanding Coverage: Conduct surveys to identify and prioritize vulnerable elderly individuals in both urban and rural settings.
- Incentivizing Volunteers: Recognizing student volunteers through appreciation certificates and potential honorariums.
- Leveraging Government Schemes: Ensuring elderly individuals benefit from available pension and welfare programs.
- Replicating the Model: Encouraging other educational institutions and organizations to adopt similar initiatives under an "Educational Social Responsibility" (ESR) framework.
- Integrating Health Services: Collaborating with ASHAs and Anganwadi workers to extend outreach and healthcare accessibility.
- Engaging Youth Organizations: Partnering with the National Service Scheme (NSS) and the Ministry of Youth Affairs to institutionalize elderly support within community service programs.

#### A Call to Action
